# PaperCut Elementary And Secondary School Emergency Relief Fund (Esser)

# Overview

The American Rescue Plan (ARP) Act of 2021 provides \$168B for Local Education Agencies and Charter Schools with LEA status to respond to the COVID-19 emergency. Funds provided to State educational agencies and school districts in the Elementary and Secondary School Emergency Relief Fund (ESSER) are intended to help schools address the impact COVID had, and continues to have, on elementary and secondary schools throughout the nation. This is in addition to the CARES Act and Covid Relief Package which was over \$300B collectively.

## FUNDING OBJECTIVES

#### Purchasing educational technology for students

Hardware, software, and connectivity to aid in regular and substantive educational interaction between students and their classroom instructors (including hybrid learning), including low income students and children with disabilities, which may include assistive technology or adaptive equipment.

#### Planning, coordination, preparedness, and response

Including activities to improve coordinated responses among LEAs and other state and local government entities, implementing summer learning an supplemental afterschool programs, providing technology for online learning in the event of long-Term closures, providing guidance for carrying out requirements under the Individuals with Disabilities Education Act, and ensuring other educational services can continue to be provided consistent with all Federal, State, and local requirements. Necessary activities to maintain the operation of schools and continuity of services.

#### Address learning loss among students

LEAs must reserve at least 20% of their allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs.

#### Training and professional development

On sanitation and minimizing the spread of infectious diseases. Providing mental health services and supports Including through the implementation of evidence-based full-service community schools.

#### Support student access to resources

Ensure access to teachers, counselors, and other school personnel to support student needs.
